**Assistant Professor (\*Technical)**

**(Age Limit-up to 35 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)**

**Essential Qualification (Technical):**

BE/B.Tech and ME/M.Tech in relevant branch with first class or equivalent either in BE/B.Tech or ME/M.Tech. from a recognized University.

**Note-1**

The exact requirement of a particular engineering discipline/branch with specialization will be indicated at the time of each recruitment.

**Note-2**

If a class/Division is not awarded, minimum of 60% marks in the aggregate shall be considered equivalent to First Class/Division. If a grade point system is adopted, the CGPA will be converted into equivalent marks as below:

**Assistant Professor (\*\*Non-Technical)**

**(Age Limit-up to 35 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)**

**Essential Qualification (Non-Technical):**

**(i) Good academic record as defined by concerned University with at least 55% marks (or equivalent grade in a point scale wherever grading system is followed) at the Master's degree level in the relevant subject from an Indian University or an equivalent degree from an accredited foreign University.**

**(ii) Passed the NET (National Eligibility Test) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.**

**(iii) Notwithstanding anything contained in (i) and (ii) above, the candidates, who are, or have been awarded a Ph. D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009, shall be exempted from the requirement of the**

minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges/ Institutions.

(iv) NET/ SLET/SET shall also not be required for such masters programme in disciplines for which NET/ SLET/SET is not conducted.

Ph.D shall be from a recognized University.

**Note – 2.**

The exact requirement of the subject / discipline of Science / Humanities, will be indicated at the time of each recruitment.

**Note -3**

**Associate Professor (\*Technical)**

(Age Limit-upto 50 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)

**Essential Qualification (Technical):**

BE/ B.Tech And ME/M.Tech in relevant branch with first class or equivalent either in BE/B.Tech or ME/ M.Tech. and Ph.D or equivalent in appropriate discipline.

Post Ph.D publications and guiding Ph.D student is highly desirable.

**Experience:-**

Minimum of 05 years experience in teaching/research/ industry of which 02 years post Ph.D experience is desirable.

**Note-1**

The exact requirement of a particular engineering discipline/ branch with specialization will be indicated at the time of each recruitment.

**Note – 2.**

If a class/Division is not awarded, minimum of 60% of marks in aggregate shall be considered equivalent to First Class/ Division. If a grade point system is adopted, the CGPA will be converted into equivalent marks as below:

Qualifications are relaxable at the discretion of the UPSC for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC for reasons to be recorded in writing, in case of candidates belonging to SC/ST, if at any stage of the selection the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

### **Associate Professor (\*\*Non-Technical)**

(Age Limit-up to 50 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)

#### **Essential Qualification (Non-Technical):**

- (i) Good academic record with a Ph.D Degree in the concerned/ allied / relevant disciplines.
- (ii) A master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- (iii) A minimum of Eight years of experience of teaching and /or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/ Industry excluding the period of Ph. D research with evidence of published work and a minimum of 5 publications as books and /or research/ policy papers.
- (iv) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided doctoral candidates and research students.
- (v) A minimum score as stipulated in the Academic Performance Indicator (API) based performance Based Appraisal System (PBAS), set out by the UGC.

Ph.D shall be from a recognized University.

**Professor (\*Technical)**

(Age Limit-upto 50 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)

**Essential Qualification (Technical):**

BE/ B.Tech And ME/M.Tech in relevant branch with first class or equivalent either in BE/B.Tech or ME/ M.Tech. and Ph.D, or equivalent in appropriate discipline.

Post Ph.D publications and guiding Ph.D student is highly desirable.

**Experience:-**

Minimum of 10 years teaching/ research/ industrial experience out of which at least 5 years should be at the level of Associate Professor.

OR

Minimum of 13 years experience in teaching and / or Research and / or Industry.

In case of research experience, good academic record and books/ research paper publications/ IPR /Patents record shall be required as deemed fit by the expert members of the Selection committee.

If the experience in industry is considered, the same shall be at managerial level equivalent to Associate Professor with active participation record in devising/ designing, planning, executing, analyzing, quality control, innovating, training, technical books/ research paper publications/ IPR/ patents, etc. as deemed fit by the expert members of the selection committee.

**Note – 2.**

For an incumbent Assistant Professor, experience at the level of Assistant Professor will be considered equivalent to experience at the level of Associate Professor, provided the incumbent Assistant Professor has acquired or acquires Ph.D degree in the relevant discipline.

**Note --6**

Experience at Diploma Institution is also considered equivalent to experience in degree level institutions at appropriate level and as applicable. However, qualifications as above shall be mandatory.

**Note—7**

Qualifications are relaxable at the discretion of the UPSC, for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

**Note—8**

The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC, for reasons to be recorded in writing in case of candidates belonging to Scheduled Castes or Scheduled Tribes, if at any stage of the selection the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

**\*Technical**—Civil Engineering, Electronics & Communication Engineering, Information Technology/Computer Engineering.

**\*\*Non-Technical**—Applied Physics, Applied Chemistry, Applied Mathematics, Economics, Communication Skills (English)

**Training & Placement Officer**

(Age Limit-upto 50 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)

**Essential Qualification (Technical):-**

BE/BTECH in Civil Engineering or Information Technology or Computer Science or Environmental Engineering and M.E./M.Tech/MBA with 1<sup>st</sup> class or equivalent either in B.E./B.Tech or M.E./M.Tech and PhD or equivalent, in Civil Engineering or Information Technology or Computer Science or Environmental Engineering.

**Experience:-**

Minimum of 10 years teaching/research/industrial experience of which at least 05 years should be at the level of Associate Professor.

OR

Minimum of 13 years experience in teaching and/or Research and/or Industry.

In case of research experience, good academic record and books/research paper publications/IPR/Patents record shall be required as deemed fit by the expert members of the Selection committee.

If the experience in industry is considered, the same shall be at managerial level equivalent to Associate Professor with active participation record in devising/designing, planning, executing, analyzing, quality control, innovating, training, technical books/ research paper publications/IPR/Patents, etc. as deemed fit by the expert members of the Selection committee.

**Librarian**

(Age Limit-upto 35 years, relaxable for SC/ST/OBC/Govt. Servant as per Govt. Norms)

**Essential:-**

1. Master's degree in Library Science/Information Science/Documentation Science or an equivalent professional degree with at least 55% marks (or an equivalent grade in a UGC point scale wherever grading system is followed) and a consistently good academic record with knowledge of computerization of Library.
2. Qualifying in the national level test conducted for the purpose by the UGC or any other agency approved by the UGC.
3. Candidates, who are, or have been awarded Ph.D. degree in accordance with the "UGC (Minimum Standards and Procedure for Award of Ph.D. Degree), Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of librarian.
